# PROGRAMME

## EPALE FOCUS GROUP

### 1. BACKGROUND

The Electronic Learning Platform for Adults in Europe - EPALE - is a multilingual community with open membership for teachers, trainers, researchers, scientists, politicians and any other person who performs a professional role in adult education and learning throughout Europe.

EPALE is an initiative of the European Commission's Directorate-General for Education, Youth, Sport and Culture. The aim of the platform is to incentivise the sharing of content amongst professionals in adult education and to allow them to network and exchange ideas and knowledge.

### 2. PRESENTATION OF THE STUDY

The study is conducted by Ramboll Management Consulting on behalf of the European Commission, Directorate-General for Employment and Social Affairs and has the aim of assessing the impact of EPALE in the first two years of the platform's operations and to explore options for improvement of the platform.

The study has a dual purpose, namely to evaluate the effectiveness of EPALE and its achievements during the first two years of operation (i.e. from January 2015 to December 2016), and to propose possible improvements to the platform.

The study relies on the findings of desk research, national and European level interviews, and online questionnaire and focus groups with stakeholder.

### 3. PRESENTATION OF THE STUDY

The focus groups will concentrate on validating the preliminary results of the analysis conducted and, in particular, on gathering data from a forward looking perspective and assessing possible options for improving the effectiveness, efficiency, coherence, added value and relevance of EPALE.

The focus groups will be conducted in three countries: Bulgaria, Malta and Italy.
